## PEFC information CD in a Finnish carton box

The new edition of the international PEFC information CD is now available (see Editors Notes for complete contents). In addition to PEFC Council's Annual Review 2006, brochures and documentation, examples of governmental recommendations for PEFC have been compiled on the CD. The CD is for everybody who wants to learn more about the advantages and benefits of PEFC's forest as well as chain-of-custody certification, its safeguards against wood from illegal logging and about the labelling of PEFC certified products.

"With our choice for the carton box we wanted to set a clear example for the use of packaging material, which is available as PEFC certified", says Mr Oliver Scholz, Communications Manager of the PEFC Council. "We are therefore proud to present our latest CD in a 100% PEFC certified carton."

The carton package for the PEFC CD (the Discbox Slider Case) is a first-ever PEFC labelled product from Stora Enso's Imatra Mills. "Stora Enso promotes all credible forest certification systems, says Environmental Director Päivi Harju-Eloranta from Stora Enso." We are delighted about the positive image of this PEFC labelled package". "It is important to note that the carton CD package is slimmer and lighter than the commonly used standard plastic case". Stora Enso Wood Supply and all Stora Enso's mills in Finland have PEFC certified chain-of-custody systems. CD carton package system is owned by Stora Enso.

# Use of PEFC certified paper is increasing

More and more printers and companies in the paper sector discover the opportunities of forest certification for their businesses. This was also one of the outcomes of a PEFC seminar, which took place in Westerlo, Belgium at the end of June.
